**Sub: Launching of National Urban Livelihood Mission w.e.f 2014-15.**


The Ministry of Housing & Urban Poverty Alleviation, Govt. of India, New Delhi has recently launched National Urban Livelihood Mission (NULM), which would replace the ongoing scheme of Swarna Jayanti Shahari Rozgar Yojana (SJSRY). The objective of NULM is to reduce urban poverty, providing shelter to the urban homeless and address the livelihood concerns of the urban street vendors. As per NULM Mission Document (Annexure-I), the NULM will be implemented in all 21 District Headquarter Towns and in Bahadurgarh (Jhajjar) being town with population above one lakh. At State level, there will be a State Mission Management Unit (SMMU) headed by Mission Director reporting to the State Principal Secretary, Urban Local Bodies and at city level, a City Mission Management Unit (CMMU) will be established in all NULM Cities to work under the overall guidance of the SMMU. As such, there is no role and provision of funds for District Urban Dev. Agency(ies) in the implementation of NULM.

2. In view of the provisions in NULM guidelines, the State Govt. has taken following decisions:
  - d) The State Urban Dev. Authority-Haryana (SUDAH) has been designated as State Urban Livelihood Mission (SULM) and State Level Nodal Agency (SLNA) for NULM. The Governing Council, Executive Council and State Technical Advisory Group of SUDAH/SULM have also been notified, circulated vide dated 04.03.2014 (Annexure-II)
  - e) All the Commissioners of Municipal Corporations and Deputy Commissioners of concerned town/cities CMCs will constitute Executive Committee and City Technical Advisory Group (CTAG) in each NULM town/city under their Chairmanship for regulating the affairs of each CMMU strictly as prescribed in NULM guidelines at para no.13.16 and 13.2 respectively.
  - f) Initially, the existing employees of SUDAH and DUDAs, who fulfills all the educational and other qualifications of specialists of SMMU and CMMU will be deputed to SMMU and to CMMUs of respective town. Other employee(s) if any, who does not fulfill the requisite qualifications of a specialist, may be deputed in Slum Clearance Board, Haryana or Haryana Urban Infrastructure Board or in Municipal Corporation(s) against vacant post. The APO/DPO of each DUDA has been designated as City Project Officer (CPO) in respective CMMU and would work under the guidance of SMMU as per provisions of NULM guidelines. The City Project Officer (CPO) will be supported by experts/ professionals (as permissible under NULM, RAY etc.) on contract basis. The City Project Officer (CPO) will also continue to discharge the duties of City Nodal Officer for the schemes of SJSRY, Urban BPL, SECC-2011, IHSDP, RAY, and RRY etc., which are presently being implemented / monitored through

DUDAs. The CPO will also be responsible for rendering the accounts and monitoring of progress of above schemes/ programmes of other towns (other than NULM towns of his District) in which any kind of funds for any purpose have been or will be released/received through DUDAs or other source. For the time being till the State and Municipal UPA Cadre is created by merging the SUDAH/DUDA staff, the salary of regular staff/employees of SUDAH/DUDAs deputed to SMMU/CMMUs would be drawn against specialists by strictly following NULM norms.

- d) In order to avoid different types of complicacies in parallel implementation of SJSRY and NULM, the NULM will be launched in Haryana w.e.f 2014-15 (1<sup>st</sup> April, 2014) by winding up SJSRY and its entire unspent balance as on 31.03.2014 shall be transferred to NULM treating it as opening balance of NULM for next FY. 2014-15.
  - e) From next FY 2014-15, no funding to non-NULM towns (except 22 towns at Annexure-III) will be allowed. However, it is clarified that SJSRY funds already released to non-NULM towns, may be utilized within current FY 2013-14 (by 31-03-2014) and any committed liability in such towns may also be met out by utilizing these SJSRY funds and thereafter utilization of SJSRY funds in these towns would not be permissible. As such, necessary directions to concerned officers/officials may kindly be issued to ensure the closure of SJSRY accounts by 07-04-2014 after proper reconciliation of figures with each quarter and submit proper and complete utilization certificate(s) clearly indicating unspent balance of SJSRY to be transferred to NULM by 10-04.2014.
3. In view of the provision of NULM guidelines and decisions of State Govt., I would request you to ensure the winding up of DUDA of your District w.e.f. 31.03.2014, calculation of exact unspent amount of SJSRY (including interest or any kind of other receipt under SJSRY) as on 31.03.2014 transferable to NULM and smooth establishment of City Mission Management Unit in each NULM towns for the implementation of NULM. 
