Subject: Implementation of ORGI software for registration & certification of birth and death in Haryana State.

On the subject noted above.

I have been directed to inform you that a meeting was held under the Chairmanship of Sh. Rakesh Gupta, IAS, APSCM on 09.10.2015 at 11:00 AM regarding Birth & Death in which it was decided to implement ORGI software developed by Gol for registration and certification of Birth & Death instead of running two different software for rural and urban areas.

A pilot project in Two ULB (Faridabad & Panchkula) will be run and will commence from 14th Oct. 2015 and 19th Oct, 2015 respectively. Tentative date of launch of ORGI software throughout the state is 1st Nov. 2015.

Moreover in the meeting it was also decided that Municipalities who were using private solution of birth and death in the past shall collect all data related to Births & Deaths Data from private agencies within three days positively.

Keeping in view of above it is requested to collect the complete data in the prescribed format (enclosed) and send the status report to Head Quarter within this period only so that APSCM could be apprised with the status. It is also requested to send the collected data in the prescribed format to Head Quarter as well as Dy. Registrar, Minister of Home affairs, Gol in soft XLS file through mail.


