

**Subject:- Release of funds under the major Head SCSP P-01-15-2217-80-789-94-51 Development of Scheduled Castes Basties grant in aid General (Plan) for the year 2015-16. (4<sup>th</sup> installment)**

Reference your single File System Dy. No.52-DLB dated 11.01.2016 on the subject noted above.

2. Sanction of Governor of Haryana is hereby accorded to release the grant in aid amounting to Rs.15,05,25,000/- (Rs. Fifteen Crore Five Lacs Twenty Five Thousand Only) for the development of scheduled Castes Basties Plan Scheme as per details enclosed in Annexure "A" for the year 2015-16 subject to the following conditions :-

- i) Director, Urban Local Bodies Haryana, Panchkula is authorized to draw the amount of grant. The utilization certificate of this amount duly verified by the concerned as case may be obtained in quarter duplicate and send to the A.G. Haryana after checking the period of utilization of grant-in-aid.
- ii) The account of the above mentioned grant in aid shall be maintained and operated separately for cent per cent check by the audit officer.
- iii) All others terms and condition issued by the Government from time to time to be strictly adhered to.
- iv) The expenditure involved is debitible under the major Head SCSP P-01-15-2217-80-789-94-51 Development of Scheduled Castes Basties grant in General (Plan) for the year 2015-16.




