

Subject:- Release of funds under the major Head "2217" Urban Local Bodies Department-800 (83) Grant in aid to Municipalities on the recommendation of State Finance Commission (09) grant in aid General (Plan) for the year 2015-16. (4th Installment) (Normal P-01-15-2217-80-800-83-51)

Reference your single File System Dy. No.51 -DLB dated 11.01.2015 on the subject noted above.

2. Sanction of Governor of Haryana is hereby accorded to release the grant in aid amounting to Rs 37,99,50,000/- (Rs Thirty Seven Crore Ninety Nine Lacs and Fifty Thousand Only) for development works in the Municipal Corporations/ Municipal Councils/ Municipal Committees under the State Finance Commission Plan Scheme as per details enclosed in Annexure "A" for the year 2015-16 subject to the following conditions :-

- i) The Director, Urban Local Bodies Haryana, Panchkula is authorized to draw the amount of grant.
- ii) The utilization certificate of this amount duly verified by the concerned as case may be obtained in quarter duplicate and send to the A.G. Haryana after checking the period of utilization of grant-in-aid.
- iii) The account of the above mentioned grant in aid shall be maintained and operated separately for cent per cent check by the audit officer.
- iv) All others terms and condition issued by the Government from time to time to be strictly adhered to.
- v) Release of funds will be debited under the Major Head Code Normal -P-01-15-2217-80-800-83-51 Urban Local Bodies Department- 800(83) Grant in aid to Municipalities on the recommendation of State Finance Commission (09) grant in aid General (Plan) for the year 2015-16.
