Both the data manually as well as uploaded online should match in all respect.
 - ii) A link has been provided in the login of each municipality on the web portal to update payment details. All the payments including interim compensation or all other instalments are to be uploaded on the online web portal. Moreover, assessed compensation amount is also to be uploaded on the web portal.
