- These rules may be called the Haryana Municipal Elections (Second Amendment) Rules, 2016.
- 2. In the Haryana Municipal Elections Rules, 1978 (hereinafter called the said rules), in rule 23A, after the word, figure, sign and letter "Form-1C", the word, figure, sign and letter "Form-1D" shall be inserted.
- 3. In the said rules after "Form -1C", the following form shall be added, namely:-

 - (ii) I have not failed to pay any arrears of any kind due to me to any Primary Agriculture Co-operative Society, District Central Co-operative Bank and District Primary Co-operative Agriculture Rural Development Bank. No dues certificates(s) from the said institutions(s) is/are enclosed.
 - (iii) I have not failed to pay arrears of electricity bills. No dues certificate from the concerned Power Utility is enclosed.
 - (iv) I have passed matriculation examination or its equivalent examination from any recognized institution/ board.

I have passed the middle class (in case of a woman candidate or a candidate belonging to Scheduled caste).

Or

I have passed the 5th class (in case of a woman candidate belonging to Scheduled caste).
