

**PUBLIC NOTICE FOR INVITING APPLICATIONS FOR GRANT OF PERMISSION FOR SETTING UP OF RECREATIONAL ACTIVITY WITHIN AVAILABLE MAXIMUM TWO FACILITIES IN A SECTOR NOT LESS THAN 200 ACRES AND MAXIMUM ONE SUCH FACILITY IN A SECTOR LESS THAN 200 ACRES IN THE RESIDENTIAL ZONE EARMARKED RESIDENTIAL SECTOR-59 of GMUC-2031 A.D UNDER POLICY DATED 27.09.2010 READ WITH POLICY DATED 10.11.2017.**

1. The Department of Town & Country Planning, Haryana has notified a policy dated 10.11.2017 for grant for permissions for which there is a cap on the Net Planned Area (NPA). 2. That the policy gives guidelines with respect to grant of permission for those categories of colonies which are to be allowed on limited area.
3. That the T&CP Department has further framed a policy dated 27.09.2010 for grant of permissions for setting up of recreational activity in residential sector. This policy allows grant of permission for setting up of recreational activity maximum two facilities in a sector not less than 200 acres and maximum one such facility in a sector less than 200 acres.
4. That in view of provisions of the policy mentioned above, the applications are invited herewith for grant of permission for setting up of recreational activity in the open space zone earmark in sector-59 (maximum two facilities in a sector not less than 200 acres and maximum one such facility in a sector less than 200 acres) can be consider for the recreational activity in the Residential zone, Sector-59, Gurugram. The applications are to be submitted in the office of Director, Urban Local Bodies, Haryana (the application in this regard is to be submitted through the online mode on the CLU portal i.e. <https://ulbcluhry.org>). That No application so received, after expiry of two months period from publication of this notice shall be considered. That, further, it is intimated that the application received online shall only be considered after a period of two months.
5. That the exact available area (CLU permissions for Recreational Purposes may be allowed in such areas designated under sub-head "730: Green Belts, Gardens and other Recreational Uses" for a maximum two facilities in a sector not less than 200 acres and maximum one such facility in a sector less than 200 acres) will be subject to decision on the applications to be decided with department. The received under this window shall only be examined for the balance available area in respective sector and shall be decided as per Act/Rules and Policies.
6. That the window of two months from the date of publication of this notice is given to the persons/companies /firms/trusts etc. who are interested in seeking permissions for the recreational activity in the residential sectors in the sector-59, Gurugram under policy dated 27.09.2010 read with policy dated 10.11.2017.
