Subject:- Status of State Single e-Procurement Portal i.e. <http://haryanaeprocurement.gov.in> being managed by Managed Service Provider (MSP) M/s Nextenders as on 19.05.2019.

The State Government vide its order No.5/1/2014-4Ib-II dated 11.02.2014 implemented the e-Procurement System through Single Web Portal ([haryanaeprocurement.gov.in](http://haryanaeprocurement.gov.in)) for the State Government and its Agencies for procurement of (i) Goods & Stores, (ii) Works, and (iii) Services. The duration of this project was five years to be counted from the date of go-live for the Pilot Department. The Portal went live on 20.05.2014 and will be completing its five years of operation on 19.05.2019.

In this regard, I have been directed to convey as under:-

1. The State Government has decided that all Govt. Departments/Boards/Corporations/Universities etc who are presently on-boarded on the State Single e-Procurement Portal (<https://haryanaeprocurement.gov.in>) will migrate to NIC e-Procurement Portal (<https://etenders.hry.nic.in>) w.e.f 20.05.2019. In view of the same, all the new tenders/auctions will have to be uploaded on NIC e-Procurement Portal (<https://etenders.hry.nic.in>) w.e.f 20.05.2019. It is further informed that all the existing tenders/auctions already uploaded prior to 20.05.2019 on the State Single e-Procurement Portal will continue to be processed till their finalization
2. 
