Minutes of 1"Meeting of State Level Committee constituted in compliance of NGT orders dated 16.01.2019 in the matter of OA No. 606 of 2018 held under the Chairmanship of Justice Pritam Pal, Former Judge of Punjab and Haryana High Court (Retd.) on 11.02.2019 at 2.00 PM in Conference room of Directorate of Urban Local Bodies, Sector-4, Panchkula.

A meeting was held under the chairmanship of Justice Pritam Pal, Former Judge of Punjab and Haryana High Court (Retd.), at 2:00 PM on 11.02.2019 in Conference room of Directorate of Urban Local Bodies, Sector-4, Panchkula., with the State Level Committee Members formed as per the NGT Order dated 11.02.2019 to review the status and progress in the implementation of Solid Waste Management Rules, 2016 in the State of Haryana, as per the directions of Hon'ble NGT dated 16.01.2019, in OA No.606/2018 in the matter of 'Compliance of Solid Waste Management Rules, 2016'. The list of participants is attached as **Annexure-I.** Important points discussed and decisions taken during the meeting are as below.

- The Chairperson apprised the committee members on the objective of the State Level Committee and the important directions passed under the NGT Orders dated 16.02.2019 which needs to be taken up with utmost priority.
- Member Secretary, HSPCB informed that as per the orders of Hon'ble NGT the State Level Committee and District Level Special Task Forces for enforcement of the rules and IEC campaigns have been proposed and the same will be notified soon by the Environment Department after approval from the competent authority.
- 3. PSULB further apprised about the current status of Solid Waste Management in the State in compliance to Solid Waste Management Rules, 2016 and the directions of Hon'ble NGT issued on 16.01.2019. It was informed that the State of Haryana has 81 Urban Local Bodies (ULBs) and all the ULBS have been divided into 14 clusters. It was further informed that the proposed Integrated Municipal Solid Waste Management plan covers 100% processing of municipal solid waste through waste to energy plants and waste to compost plants. Out of these 14 clusters, 4 clusters namely, Gurugram- Faridabab, Panipat-Sonepat, Rohtak and Ambala-Karnal will have waste to energy plants and other 10 clusters will have waste to compost plants. The time bound monthly action plan for execution of all the 14 Cluster projects has been prepared and submitted to HSPCB for further necessary action. Along with the cluster approach, individual ULB level approach has also been adopted for Haryana State and city level action plans have been prepared.
- 4. It was also informed that for setting up Integrated Solid Waste Management processing facilities and common sanitary landfill for all the 14 clusters, lands have already been identified and the process of obtaining Environmental Clearance is under progress.
- 5. It was further briefed that apart from the cluster approach and to ensure compliance of SWM Rules, 2016 in individual ULBs a State Policy and strategy for solid waste management, bye-laws and a time bound action plan with proposed target dates for achieving 100% door-to-door collection, source



segregation, processing and disposal has already been prepared until the Cluster Projects are awarded and completed. The individual ULB wise action plan has already been circulated to all the ULBs for validation and resolution.

- Thereafter, a presentation was given by the Transaction Advisor covering immediate future plan with proposed timelines for achieving 100% door to door collection, secondary lifting and transportation, compartmentalization of all the vehicles, Source segregation, elimination of garbage vulnerable points, identification and 100% processing by Bulk Waste Generators, prescribing user fees, setting up atleast one processing and material recovery facilities in each town and city for processing and disposal. It was also informed that for Bioremediation of existing dumpsite the bid document is under approval stage from the competent authority and upon approval the tender will be floated for remediation of Panchkula Dumpsite in first phase. The target for achieving compliance of these parameters is by September 2019.
- The ULB department informed that for controlling Plastic Waste generation the Urban Local Bodies Department has notified vide notification dated 20.07.2013 regarding complete ban of manufacturing, stock, distribute, sell or use of all kind of plastic in the urban areas. Directions have been issued to all the ULBs vide this office memo no. DULB/XEN-I/2018/9339 dated 24.08.2018 for implementation of provisions made under Plastic Waste Management Rules, 2016.Also a State Level Advisory Committee has been formed for implementation of Plastic Waste Rules 2016 and first meeting was held on 30th January 2019.The draft bye-laws for PWM is under preparation and shall be notified by March 2019.
- 8. Further it was informed that MC Gurugram has already taken the initiative to use plastic waste in road construction and setting up of Plastic Waste Collection centers is under progress. The same practice shall be replicated in other ULBs aswell. Also under CSR initiative some of the ULBs are distributing the recyclable handmade bags to limit the use of plastic bags. The ULBs are identifying and registering the rag pickers and Kabariwalas's for collection and segregation of plastic waste. The challans are also being imposed on the violators as per provision of the Rules.
- 9. For management of C&D waste the ULB department informed that 7 ULBs namely HailyMandi (1 site), Hisar (1 site), Bahadurgarh (1site), Gurugram (15 sites), Pataudi (1 site), Sohna (2 sites), Farukhnagar (1 site) and Karnal (1 site) have identified and notified designated collection centres for collection and storage of C&D Waste. The remaining ULBs are in the process of identifying and procuring suitable land for C&D waste management. Gurugram has already awarded execution of 300 TPD C&D plant to private developer. The model Request for Proposal for inviting tenders for C&D Waste management facilities has been prepared by the Urban Local Bodies for ULBs having population more than 5 lakhs. Also mobile C&D waste plants are under procurement in Gurugram. In the first phase proposal for 3 ULBs is likely to be invited by March 2019 after obtaining approval from the competent authority.



- The chairperson then directed that the violators pertaining to SWM, Rules 2016, PWM Rules 2016, BMW, Rules 2016 and C&D, Rules 2016 may not be spared at any cost and must be fined immediately as per the provision stipulated under the Rules. Also proper record with no. of fines along with the list of violators and fine imposed under violation of different Rules must be prepared and presented to the committee before every meeting of SLC. Also wide publicity be given regarding the same to make waste generators aware of the consequences for not complying with Rules, he advised.
- 11. The Chairperson decided that the monthly State Level Committee meeting will be held on second Tuesday of every month. The chairperson also directed Environment Department to ensure that the district level committees must send the monthly progress report to State Level Committee as directed by Tribunal in its order dated 16.02.2019 before the SLC meeting every month.
- 12. It was decided that all Departments concerned shall nominate a Nodal Officer who shall coordinate with all their field units, compile reports and send to the Committee. The details of Nodal Officer be sent to HSPCB positively in a week time.
- 13. Chairman further informed that he would be undertaking field tours and hold meetings with Deputy Commissioners of individual districts. The Nodal Officers and Administrative Secretaries shall coordinate the same.
- 14. He further directed that as per the orders a separate website must be developed to upload minutes of the SLC meeting, the action taken report along the status as well as progress made in the compliance of Solid Waste Management Rules, 2016. ULB Department may coordinate the same with Environment Department and HSPCB and ensure the uploading of the status reports from time to time, it was decided.
- 15. The Development and Panchayats Department has not submitted any action plan to HSPCB yet, as mandated by the provisions of Solid Waste Management Rules, 2016. The Department was advised to submit the same immediately.
