


Step By step Procedure for application filling and internal processing of application by Department

2. Principal Secretary to Government Haryana, Electronics and Information Technology Department vide letter no. PS/PSIT/2017/134 dated 09.05.2017 that Hon'ble Chief minister, Haryana has taken a very serious view on the various services which are being provided manually or in an offline mode in spite of fact that these services have already been declared online along with time lines notified under Right to Service Act and desired that no such service is offered manually or offline mode.

I have been directed to inform you that Government took a decision that service as given below which were developed and rolled by the Head office shall only be used for offering services to the citizens and none of the service is offered in manual or offline mode:

- a) Birth & Death Registration and Certification (CRS DRGI Software)
- b) Marriage Registration and Certification
- c) Approval of Building plan
- d) Issuance of Occupation Certificate
- e) Approval of Fire Fighting Scheme
- f) Issuance of Fire NOC
- g) Business License in case of Municipal Corporations
- h) Water and sewer connections in case of Municipal Corporation Faridabad and Gurgaon



In India, Urban Local Bodies are the constitutionally provided administrative units, who provides basic infrastructure and services in urban areas i.e cities and towns. For urban areas, administration of basic civic amenities like water supply, drainage, public health and sanitation are also essential.

To have better co-ordination and control on the working of municipalities in the State, the Directorate of Urban Local Bodies Department, Haryana was established on 1st April, 1982. The Department was established to give impetus to the 74th Amendment of the Constitution and to lay a solid foundation for the Urban Development in the State of Haryana. Haryana is one of the most progressive States in India and its people are quite proactive in keeping themselves abreast of the changing global landscape. With rapid urbanization, growing needs of the citizens for efficient & effective service delivery, better civic amenities thereby providing better living standards, the activities of the department have multiplied manifolds. In view of the satisfactory fire protection system / arrangement mentioned as above, this office has No objection for occupation of Building from the Fire Safety point of view, with the following conditions:-

- 1) The owner/occupier shall keep duly trained Fire Staff in all three shifts.
- 2) The Fire Protection System tested during inspection shall be maintained properly & always should be in good working condition.
- 3) If any lapse is found in the fire protection system at the time of inspection or detected during outbreak of fire, action will be taken as per rules against you.
