Please refer to this UO dated 19.08.2021 vide which the undersigned has been appointed as Nodal Officer for deciding "Objection Applications" on NDC portal.

With regard to the above, it is to inform that the undersigned has observed that the
application prepare by maker and verified by checker has following deficiencies and
prepared the following checklist of the mandatory documents required along the
compliance of the listed deficiencies for approval of the NDC application;

In view of the above, it is requested that maker and checker shall ensure up oading of the above said information/ documents with NDC application, so that NDC objection application can be dealt timely and rightly. NDC application without the above said information/ documents will be rejected and the applicant has to apply fresh with the requisite information and documents.

  - a. List of colonies notified in the year 2004, copy of the notified colony with Khasra no.
     and copy of its approved layout plan (duly signed/ verified).
  - Copy of notification of colonies notified in the year 2013-2014, along with its approved layout plan (duly signed/ verified).

c. Copy of notification of colonies notified in the year 2017 to 2019, along with its approved layout plan (duly signed/ verified).
