No. 14/2/2020-3C-II/29212 - In exercise of the powers conferred by clause (xv) of sub-Section (1) of Section 70 read with sub-Section 1 of Section 84 of the Haryana Municipal Act, 1973 (24 of 1973) the Governor of Haryana is pleased to make the following amendments in the Haryana Government (Urban Local Bodies Department) Notification No. 14/2/2011-3C-II dated 9th March, 2011 and Notification No. 14/2/2015-3C-II dated 11th March, 2015 with immediate effect, namely: -

Amendment

In the Haryana Government (Urban Local Bodies Department) Notification No. 14/2/2011-3C-II dated 9th March, 2011 and Notification No. 14/2/2015-3C-II dated 11th March, 2015.

i. Regularisation of illegal water & sewerage connections: -

No road cut charges and no connection fee will be levied by Municipal Councils & Committees for new as well as regularisation of unauthorized non bulk water & sewerage connections till 31.08.2020.

In case of non-compliance by 31.08.2020, a penalty equal to twice the water and sewerage connection fees be levied and bills be raised at flat rate charges.

ii. Provision of one-time settlement of dues:-

A one-time rebate of 25% on cumulative arrears is also allowed on the bills for the period upto 31.03.2020, if the same is paid by 31.08.2020 alongwith upto date current payment of the bill. Municipalities shall ensure that bills be raised for water and sewerage for the period ending on 31.03.2020 clearly deducting the 25% cumulative arrears within one month of issuance of this policy.

iii. In case total dues are not paid by the due date i.e., 31.08.2020, such connection will be disconnected also.

iv. Provision be made for online application for release of connection, payment of dues as well as mapping of the each unit of water connection ID with the property tax ID.
