Sub: Directions regarding abatement of Air Pollution in Gurugram and implementation of revised GRAP issued by CAQM.

Please refer to the subject noted above, it is intimated that a meeting was held on 03.10.2022 under the Chairmanship of undersigned, list of participants is attached as **Annexure-A**, regarding implementation of directions of CAQM including revised GRAP (**Annexure-1**) and it was decided that all the departments will appoint a Nodal Officer, inform their name alongwith mobile no. & email address for implementation of revised GRAP directions and submit Daily action taken report by 03:00 PM to HSPCB, Gurugram Region (South) on the prescribed performa (**Annexure-2**) through email hspcbrogrs@gmail.com. Accordingly HSPCB, Gurugram Region (S) will compile the information and send it to DPRO, Gurugram by 03:30 PM. DPRO, Gurugram will publish on behalf undersigned. Whatsapp group should have all nodal officers as Members.

Further, incident of fire be extinguished by fire Department immediately as and when comes into notice by anyway & complaints on Sameer app will be addressed promptly without any delay by all concerned. Compliance of directions of CAQM should be ensured implemented with true letter & sprit by all agencies / Departments / Officers concerned. Nodal Officer of concerned department shall be responsible for ensuring implementation of directions issued in this regard and shall initiate appropriate action against the concerned quarters/agencies for not adhering these directions.

Violations of Construction & Demolition activities having built up area less than 20000 Sqm shall be implemented by concerned agencies in their respective jurisdiction by GMDA/MCG/MCM/Municipalities/DDPO/HSVP/DTCP etc and more than 20000 sqm area shall be looked into by HSPCB/DTCP.

Regulation of DG sets shall be implemented by concerned agencies in their respective jurisdiction by GMDA/MCG/MCM/Municipalities/DDPO/HSVP/DTCP etc except industries/establishments covered under ambit of HSPCB shall be looked into by HSPCB and Department of industries shall implement in remaining industries/establishments which are not covered under ambit of HSPCB.
