Office Order

In compliance of the provisions of Haryana Municipal Citizen's participation Act, 2008, Municipal Committee, Sampla has decided to constitute the Area Sabha for each ward to ensure the citizen participation in the development works as well as to facilitate the citizens for providing the ~~benefits~~ ^{benefits} of various Government Schemes at the local level.

2. The duties and functions of the Area Sabha within their jurisdiction area has been mentined in section 8 of the Haryana Municipal Citizens' Participation Act, 2008, which are reproduced as under:-

- to generate proposals and determine the poiority of schemes and development programmes, to be implemented in the area and forward the same to the ward committee, or in its absence, the municipality, for inclusio in the development plans of the ward committee or municipality, as the case may be;
- to verify the most eligible persons from the area for beneficiary-oriented schemes on the basis of criteria fixed by the Goernment and prepare a list of eligible beneficiaries in order of priority and forward the same for inclusion in the development plans of the ward or municipality;
- to suggest the location of streetlights, streets, community water taps, public wells, public sanitation units and such other civic amenity schemes within the area;
- to identify the deficiencies in the civic amenities in the area and suggest remedial measures;
- to assist the activities of public health centres in the area, especially in disease prevention and family welfare and create arrangements to report on the incidence of epidemics and natural calamities;
- to provide and mobilize voluntary labour and contributions in cash and kind for development programmes and to supervise such development works through volunteer teams;
- to undertake and support tax mapping and to remind people of the locality of their obligations to pay municipal taxes and user charges.

3. Accordingly, the Area Sabha for each ward of Municipal Committee, Sampla, is hereby constituted as follows:-
