2. Permission for change of land use for setting up of an Industry (Auto Mobile servicing, repairing and painting having quantity of waster water generation upto 100 KLD) comprised in Khasra no. 282//23/1, 318/3/1/1, (3972.10 sq.mtrs) in the revenue estate village Fatehabad Tehsil & District Fatehabad situated in Industrial zone, Sector-1, Fatehabad as per Final Development Plan Fatehabad 2031 AD is here by granted under the provisions of Section 203 E(2)(a) of the Haryana Municipal Act, 1973, after receipt of Rs. 1,19,163/- on account of conversion charges and and Rs. 5,10,591/- on account of 10% of the gross payable amount of EDC of Rs. 51,05,909/-
3. This permission is further, subject to the following terms & conditions:
 - i. That the conditions of agreement executed by you with the Director, Urban Local Bodies Haryana and the provisions of the Haryana Municipal Act, 1973 are duly complied with by you.
 - ii. That you shall pay the additional amount of conversion charges and External Development Charges for any variation in the area of site in lumpsum within 30 days as and when detected and demanded by the Director, Urban Local Bodies, Haryana, Panchkula.
 - iii. That you shall deposit 40% External Development Charges (updated) when the land in the sector shall be acquired by HSVP and the balance 50% of gross EDC amount, in four annual equal instalments along with an interest @ 15% p.a.
 - iv. At least 75% employment shall be given to the domiciles of Haryana where the posts are of non-technical nature and a quarterly report in this regard shall be submitted to G.M.D.I.C, Fatehabad.
 - v. That you shall deposit the Internal Development Charges as and when demanded by the Government or any of its agency i.e HSVP/ HSIIDC/ Municipal Council, Fatehabad.
 - vi. That you shall get the building plans for the site approved from the Director, Urban Local Bodies, Haryana before commencing the construction at site and will start the construction within six months from the issuance of this permission.
 - vii. That you shall obtain occupation certificate from the Director, Urban Local Bodies, Haryana after completing the construction within two years of the issuance of this permission.
 - viii. That you will pay the labour cess before approval of Building plan for the additional construction of site.
 - ix. That the development/ construction cost of 24/18 mtrs. wide road/ major internal road is not included in the EDC rates and you will pay the proportionate cost for acquisition of land, if any along with the construction cost of 24/18 mtrs. wide road/ major internal road as and when finalised and demanded by Director, Urban Local Bodies, Haryana Panchkula.
 - x. That this permission is valid for two years from the date of issue of this letter subject to fulfilment of the terms and conditions of the permission granted and agreement executed.
 - xi. That this permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.
