Sub: - Ensuring the proper arrangements at Rain Baseras (Night Shelters-NULM).

Please refer to the subject cited above.

2. You are well aware of the fact that the Ministry of Housing and Urban Affairs (NULM-MoHUA) is regularly reviewing the arrangements (specifically in winter season) made for urban homeless persons. Moreover, the winter season is ensuing, district administrations have to ensure the proper functioning of existing temporary, permanent, porta-cabins & pre-fabricated shelters and necessary arrangements for providing relief to Urban Homeless Persons. Further, awareness in ULBs have to be created about the facilities for urban homeless persons in the town.

Accordingly, you are requested to ensure the following arrangements/required actions: -

- (a) To initiate meeting of Shelter Management Committees (SMCs) in respective ULBs ahead of coming winter season and thereafter conducting SMCs meetings regularly.
- (b) Display of banners (clearly indicating the address of Shelters(s) and name & Contact number of its care taker) at prominent places like Bus stand, Railway Station, Municipal Office, important religious places, etc. It should also be ensured that the contact No. of shelter/concerned nodal officers should be working 24x7.
- (c) All the night shelter in the area should have the arrangement of well-ventilated rooms, water (potable drinking water and other needs) and sanitation, bathing & toilet facilities, standard lighting for shelter, adequate fire protection measures, first aid kit, pest and vector (mosquito) control, room heaters, regular cleaning of blankets, clean mattresses, sheets, de-addiction facilities etc.
- (d) Constitute a team of the ULB officials to visit the Municipal areas during the night to shift the Urban homeless persons into shelters/Rain Basera, who are sleeping in open areas/roadside etc.
- (e) During the process of shifting of homeless persons, the Inspecting Officer should carry sufficient number of blankets and ensure every such person (sleeping in the open, roadside, pavements, etc.) is shifted to the nearest night shelter (Rain Basera) and should be adequately protected against the cold.
- (f) To ensure daily updation of the report in the google sheet by the nodal officer w.e.f. 01.11.2023 & link of google sheet will be shared subsequently by this office.




