**Subject:- Regarding Relaxation of Model Code of Conduct for Essential Municipal Services.**

On the subject cited above.

2. With reference to the subject cited above, it is intimated that a meeting was held under the Chairmanship of W/C&S-ULB on 13.02.2025 at 03:00 PM to discuss the execution of essential municipal services such as Door to Door Collection, Transportation and processing of Municipal Solid Waste, Road Sweeping, Cleaning of Nallas, Night Sweeping and Bio Remediation of Legacy Waste, Operation and Maintenance of Sewerage System, Water Supply and Storm Water Drainage System and O&M of street lights, CCTV and other electrical works during the enforcement of the Model Code of Conduct (MCC). It was deliberated that the essential services need to be continued without interruption.

3. Therefore, I have been directed by the competent authority that, all ULBs shall carry out the inviting, opening and allotment of above said works as per above stated decision. However, any such actions taken under this relaxation shall be duly intimated to the State Election Commission.
