- 2. The main objectives of constituting these Flying Squads are as under:-
 - (a) Presently complaints regarding irregularities in development works, unauthorized constructions, illegal encroachment, sale of municipal shops under Swamitva scheme, illegal advertisements, Property Tax related issues and corruption cases are being received frequently in the Department. There is no mechanism for dealing such complaints in a time bound and transparent manner at the level of department. Many Government agencies are involved in checking the grievances & complaints lodged by public against municipality staffindulging in malpractices/corruption. This tarnishes the image of municipalities as well as the Department in the eyes of general public.

Hence, to curb such activities made by unscrupulous staff, a mechanism has to be evolved and accordingly, it has been decided to constitute Flying Squads for each district headed by a senior Officer as mentioned above.

- It will also send a clear message down the line that corruption & n alpractices by the staff of the municipalities shall not be tolerated and strict action will be taken aga nst such unscrupulous
- The scope of functioning of these Flying Squads shall be as under:-3.

To inquire and check the status of complaints in respect of municipalities of the (i) district forwarded by the Department.

(ii) To randomly check & verify unauthorized constructions & illegal encroachments on municipal land within municipal limits of the district by conducting spot inspections at the time of their visit.

To check un-authorized advertisements operating in municipal areas within (iii) municipal limits of the district during their visit and after getting verified, forward the report to Directorate of Urban Local Bodies, Haryana.

To check the development works completed or under execution within municipal (iv) limits of the district during their visit as per details provided by Headquarter and after getting verified, forward the report to the Directorate of Urban Local Bodies, (v)

To check the attendance of the municipal staff during their visit.

Any other tasks assigned by the Director, Urban Local Bodies, Haryana. (vi)

- The concerned District Municipal Commissioners and Commissioners of Municipal Corporations shall provide all required assistance including deployment of sufficient number of staff to them during their
- If any Officer is transferred/retired, then the new incumbent in his/her place shall automatically be the Head of the said Flying Squad.
- 6. The Flying Squad Officers shall visit for full day as & when required to inquire into any complaint forwarded by Director, Urban Local Bodies, Haryana. Besides the complaint, other matters/ issues as enumerated at Para 3 above shall also be looked into and report in this regard should be submitted to Directorate of Urban Local Bodies, Haryana at email id : cvodulb@gmail.com for onv/ard submission to the
