It is informed that following posts of Executive Engineers, Assistant/Municipal Engineers and Junior Engineers are lying vacant in various municipalities in the State under administrative control of Urban Local Bodies Department which are to be filled up by way of deputation initially for a period of one year, likely to be extended as per the Government instructions/rules :-

It is, therefore, requested to send the panel of such employees working in your office, who fulfil the above said conditions for the concerned post and are willing to serve on deputation basis in various municipalities in the State. It is also mentioned here that the panel of such employees may be sent to this office **upto 10.03.2022** with your recommendation alongwith last five years attested ACRs summary and certify that no disciplinary action/criminal proceeding is pending against the officer/official. Further, the consent of the employees who intend to work on deputation basis in municipalities may also be sent. The applications received through proper channel will only be considered.
