Bulletin COVID-19 Dated 29.09.2020

Details of the activities being carried out by the Urban Local Bodies Department are as follows:

Urban Local Bodies are ensuring to provide essential services to the citizens in all the 87 Municipalities of the State having 10 Municipal Corporations, 19 Municipal Councils and 58 Municipal Committees, during the lockdown period on account of COVID-19 pandemic.

All 87 ULBs are tirelessly working towards cleaning and disposing off the Municipal Waste and **90-100%** Solid Municipal Waste is being collected and disposed off regularly.

 Mechanical Sweeping (In Kms.): ULBs are deploying mechanical sweeping machines for cleaning of main roads and approximately 949 KMs of roads on per day basis are being swept and cleaned regularly.



Disinfecting activities:

The ULBs are regularly disinfecting all public places such as Bus Stands, Railway Stations, Markets, Government Offices, Malls, Colonies and Public & Community Toilets etc.

Currently, third round of disinfection activities are being carried out across all the ULBs.

Night Shelters:

Stay at Rain Baseras/Community Centres is being provided by assisting District Administration to the migrating labour/stranded people etc. Cleaning & Fumigation at each Centre is being ensured by Municipalities on daily basis. Since March, in a day maximum of **8,800** people have stayed in approximately **321** Rain Baseras established across 87 ULBs.
