Permission for change of land use for setting up of Local Service Industry (Bakery Product Unit) over land falling in the revenue estate of village Badshahpur, Tehsil Badshahpur, Distt. Gurugram - Vinay Mangla S/o Raj Kumar Mangla.

- Permission for change of land use for setting up of a local service industry (Bakery Product Unit) over land measuring 876.34 sq.mtrs (after excluding an area measuring 899.16 sq. mtrs falls under 30 mtr. wide green belt and Service road and an area measuring 20.28 sq. mtr. falls under 24 mtr. wide proposed road) comprised in khasra nos. 132//23/1/2 & 23/2/1 of revenue estate of Village Badshahpur, Tehsil Badshahpur, Distt. Gurugram (Residential sector 68, Gurugram), is hereby granted as per provision under Section 349(2) (a) of the Haryana Municipal Corporation Act, 1994 after receipt of Rs. 87,634/- on account of conversion charges and Rs. 3,75,496/- on account of 10% of the gross payable amount of External Development Charges of Rs. 37,54,966/-.
- 2. This permission is further, subject to the following terms & conditions:
- 3. That the conditions of agreement executed by you with the Director, Urban Local Bodies, Haryana, Panchkula and the provisions of the Haryana Municipal Corporation Act, 1994 are duly complied with by you.
- 4. That you shall pay the additional amount of conversion charges and External Development Charges for any variation in the area of site in lump sum within 30 days or as and when detected and demanded by the Director, Urban Local Bodies, Haryana, Panchkula.
- 5. That You shall deposit 40% EDC (updated) shall be deposit before approval of building plans or within six months of grant of CLU permission and the balance 50% (updated) before issuance of occupation certificate or within two years from the grant of CLU permission whichever is earlier.
- 6. That you shall give at least 75% employment to the domiciles of Haryana as per the provisions of Haryana State Employment of Local Candidates Act, 2020. A quarterly report regarding the employment shall be furnished to the Joint Director, District Industries Centre, Gurugram and on designated portal in such form as prescribed by the competent Authority under the provision of Haryana State Employment of Local Candidates Act, 2020.
- 7. That you shall get the building plans for the site approved from the Commissioner, Municipal Corporation, Gurugram before commencing the construction at site and will start the construction within six months from the issuance of this permission.
- 8. That you shall obtain occupation certificate from the Commissioner, Municipal Corporation, Gurugram after completing the building within two years of the issuance of this permission.
- 9. That you will pay the labour cess before approval of building plan.
- 10. That you shall not object acquisition of land from your site whenever required for road widening in future by any Government agency.
- 11. That the development/ construction cost of 24/18 mtrs. wide road/ major internal road is not included in the EDC rates and you will pay the proportionate cost for acquisition of land, if any along with the construction cost of 24/18 mtrs wide road/ major internal road as and when finalised and demanded by Director, Urban Local Bodies, Haryana Panchkula.
- 12. This permission shall be valid for two years from the date of issue of this letter subject to fulfilment of the terms and conditions of the permission granted and agreement executed.
- 13. That this permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.
