Subject: Constitution and notification of Area Sabhas in Municipal Corporation, Faridabad – Ward No. 01 to 46 – Including complete Area Sabha-wise details, and specification of functions and duties of Area Sabha and Member Secretary.

In exercise of the powers conferred under the Haryana Municipal Citizen Participation Act, 2008, read with the relevant provisions of the Haryana Municipal Corporation Act, 1994, and in compliance with the directions issued by the Directorate of Urban Local Bodies, Haryana, the undersigned is pleased to hereby constitute and notify the Area Sabhas in the jurisdiction of Municipal Corporation, Faridabad, as per the details given herein below.

1. Constitution of Area Sabhas

- 229 Area Sabhas are hereby constituted for all Wards No. 01 to 46 of Municipal Corporation, Faridabad.
- Each Ward has been divided into multiple Area Sabhas, ensuring:
- Population of each Area Sabha remains within prescribed norms,
- Polling Booths are kept intact (no booth breakup),
- Logical and compact territorial jurisdiction.

2. Area Sabha-wise Complete Particulars

The complete details of each Area Sabha, including:

- Ward Number
- Area Sabha Number (e.g. 1/1, 1/2, ...)
- Polling Booth numbers included in the Area Sabha
- Population of the Area Sabha
- Number of voters / members of the Area Sabha (as per electoral roll)
- Name, designation and mobile number of Member Secretary (Municipal Employee) are hereby notified ward-wise and enclosed as ANNEXURE-A (Ward-wise), forming an integral and inseparable part of this Order.

Ward-wise Annexures

- Annexure-A1 : Ward No. 01 to 46 – Area Sabha details
- Annexure contains Area Sabha No., Booth Nos., Population, Voters/Members and Member Secretary exactly as approved.

3. Members of Area Sabha

- All persons whose names appear in the latest electoral roll of the Polling Booths included in an Area Sabha shall be deemed to be Members of that Area Sabha.

4. Functions & Duties of Area Sabha

The Area Sabha shall perform the following functions, namely:

- I. To identify and prioritise local civic needs and issues of the area
- II. Monitoring of implementation of Govt. schemes 1. Verification/ validation of old age Pension , Deendayal Lado Laxmi Yogna , Widow Pension Beneficiary.
- III. To assist the Municipal Corporation in preparation and monitoring of ward-level development works

- IV. To promote citizen participation in sanitation, solid waste management, water supply, street lighting and public health activities
- V. To provide feedback on delivery of municipal services
- VI. To suggest measures for social welfare, cleanliness, environment protection and public convenience
- VII. To facilitate transparency and accountability at the grassroots level
- VIII. Any other function assigned by the Municipal Corporation or competent authority

5. Appointment & Duties of Member Secretary (Municipal Employee)

- The Municipal Employee mentioned against each Area Sabha in the respective Annexure is hereby designated as Member Secretary of that Area Sabha.
- Duties & Responsibilities of Member Secretary

The Member Secretary shall:

- Maintain Area Sabha records, registers and database
- Coordinate convening of Area Sabha meetings as per directions
- Record proceedings, suggestions and resolutions of the Area Sabha
- Forward issues and resolutions to the concerned Zonal Office / Branch
- Ensure follow-up action and status reporting
- Act as a liaison between citizens and Municipal Corporation
- Perform any other duty assigned by the Commissioner or competent authority

6. Basis of Data

The population and voter figures mentioned in the Annexures are based on:

- Latest available ward population data, and
- Final electoral roll received from the Election Branch.
- Any subsequent change due to revision of electoral roll or administrative rationalisation shall be incorporated with approval of the competent authority.

7. Publication & Enforcement

This Order shall come into force with immediate effect.

The Order shall be:

- Circulated to all concerned officers and branches,
- Displayed on Notice Boards of MCF and Zonal Offices,
- Uploaded on the official website of Municipal Corporation, Faridabad.
