Subject: * Unauthorised colonies.

In continuation to DULB office memo no. CTP/A3/2008/48466-540, dated 25.11.2008 (copy enclosed) on the cited subject.

Director, Urban Local Bodies Haryana has already issued instructions vide memo under reference that no development works such as roads, street lights, parks, open spaces, water supply, sewerage system etc. would be carried out in unauthorized colonies by the Municipalities. However, it has been observed that despite clear directions from the Directorate some Municipal Corporations/Councils/ Committees are carrying out the development works in the unauthorized colonies. It has been viewed very seriously by Principal Accountant General (Audit) Haryana as well as the Government.

either needs a license under Section 3 of the Haryana Development and Regulation of Urban Areas Act, 1975 (Act No 8 of 1975) or has to get a Town Planning Scheme approved under the Municipal Acts. Any colony carved out without obtaining requisite approval of the Government amounts to violation of Section 7(i) of the Act ibid and is termed as unauthorized colony and offence is punishable upto 3 years of imprisonment under Section 10, 11 and 12 of Act No. 8 of 1975. An action amounting to abetment of an offence is also equally punishable. In case cognizance of any such action is taken by the Courts erring officer/ official shall be personally liable for the same.

It is, therefore, reiterated that it should be ensured that development works should not be made in unauthorized colonies.
