## Expression of Interest -Cow Dung Waste Management

Municipal Corporation Faridabad intends to streamline the process of collection of cow dung from dairies and other households engaged in dairy farming. As per the current on-ground situation, there is no mechanism to separately handle and manage the cow dung. Thus, the mismanagement due to improper disposal of cow dung causes blockage of drains and affects the sewage system adversely. In compliance with Solid Waste Management Rules, 2016, proper channels for cow dung collection and disposal needs to be finalized.

## 1.0 Scope of Work

The following types of works shall be expected from the agencies to be onboarded:

- Door-to-door collection & transportation of cow dung from dairies and households practicing animal husbandry and dumping to sites designated by MCF at fixed price of Rs. 250/- per animal per month (or as decided by MCF from time-to-time) in the ward(s)/cluster(s) assigned to the said agency, and/or,
- 2. Setting up and Operation & Maintenance of cowdung processing facility to manufacture products such as bio gas, bricks, logs, cow dung soaps, shampoos, toothpaste, shaving creams, sunscreens, face washes, teas, incense sticks and bio fertilisers, etc. All the expenditure to set up and run the project shall be incurred by the agency. MCF shall not undertake any financial or human resource liability to set up or run the project. Only right to utilise the collected cow dung and land for the purpose of running such facility shall be provided by MCF. The agency shall also reserve the right on the revenue generated from manufacture of such products. Any claim for buy back guarantee or compensation of any kind of loss shall not be entertained by the Corporation.

**Please Note:** Only 1 vendor per cluster shall be authorised for the said purpose. The successful vendor will have to take all other private vendors under its umbrella.
