Directions were also issued that the online applications which have been developed and rolled out by Head Office should be use while offering online services to the citizen and none of such service should be offered manually.

- 2. As per MIS report available on Dash Board, it is observed that some of the ULBs have not yet adopted online services developed and rolled out by Head Office and still delivering the services in manual mode.
