**No. 18/150/2020-3C1** - In exercise of the powers conferred by clause (ii) of sub-section (1) and sub section (2) of section 2A read with section 3 of the Haryana Municipal Act, 1973 (24 of 1973), the Governor of Haryana hereby declare the area of Kalka Zone and Pinjore Zone of the erstwhile Municipal Corporation, Panchkula with the boundaries as specified in the Schedule given below, as Municipal Council, Kalka.

**SCHEDULE OF BOUNDARIES**

**North:-** Starting from point 'A' i.e. North East corner Khasra No. 432 of village Basawal on the Eastern side of National Highway-21-A towards East along boundary line of village Basawal from North East corner of Khasra No. 533 to South ward boundary of village Basawal towards North West corner of Khasra No. 581 and then upto North West corner of Khasra No. 1 of village Tagra Kangan upto Sahadda (Trijunction) of Basawal, Deh Haja Majra Mehtab then towards East along revenue boundary of village Tagra Kangan and village Majra Mehtab upto North East corner of Khasra NO. 105 of village Tagra Kangan then from North West corner of Khasra No. 86 of village Kanguwala Hadbast No. 146 upto Sahadda Tagra Kangan Deh Haja Majra Mehtab. Thence towards East along revenue boundary of village Kanguwala and Majra Mehtab upto Khasra No. 102/80 of village Kanguwala upto Sarhade Kandiala thence towards East along Khasra No. 102/80 of village Kanguwala upto Sahadda Orian Deh Haja Kandiala, thence towards East along North East corner of Khasra No. 79 village Kanguwala and North West corner of Khasra No. 1/1 of village Kalka upto Sahadda Kanguwala Deh Haja Orian thence towards East along of revenue boundary of village Kalka and village Orian upto Khasra NO. 2/6 of village Kalka i.e. Sahadda Orian Deh Haja Khera Sita Ram. Thence towards East along revenue boundary of village Kalka (except Area under forest), North West corner of Khasra No. 83/66/20/1/1 of village Khera Sita Ram Hadbast NO. 148, North East corner of Khasra No. 67/20/2/1 of village Khera Sita Ram. Thence towards South along Eastern boundary of Khasra No. 69/43/25 of village Khera Sita Ram upto Sahadda Deh Haja Ambctha Himachal Pradesh. Thence towards South along boundary of Himachal Pradesh and village Khera Sita Ram upto North East corner of Khasra No. 31 of village Khera Sita Ram i.e. Sahadda Ambotha Deh Haja Jungle Sarkar, which is point 'B'.

**East:-** Thence from point 'B' towards South upto North East corner of Khasra No. 54/40 of village Khera Sita Ram i.e. Sahadda Ambotha Deh Haja Guma Himachal Pradesh thence towards West along Eastern boundary of Khasra no. 32 of village Khera Sita Ram and along

the boundary between Khasra No. 73/53/40,74/53/40 of village Khera Sita Ram and reserve forest towards South East corner of Khasra No. 75/53/40 of village Khera Sita Ram and along Eastern boundary of Khasra No. 87 of village Bhairon ki Ser Hadbast No. 149 upto Sahadda Khera Sita Ram Deh Haja Jungle Sarkar. Thence towards South along South East corner of Khasra No. 87 of village Bhairon ki Ser and North East corner of Khasra No. 85 of village Tipra Hadbast No. 157 upto Sahadda Bhairon ki Ser Deh Haja Jungle Sarkar. Thence towards South along boundary of Khasra No. 85 of village Tipra upto Sahadda jungle Sarkar Deh Haja Guma thence towards South along boundary of Himachal Pradesh and Khasra No. 139 of village Tipra upto Sahadda Goma Deh Haja Khadin (H.P.) thence towards South along boundary of village Tipra and villag Khadin (H.P.) upto Khasra No. 116 of village Tipra i.e. Sahadda Kanguwala Deh Haja Jaithal and then upto North East corner of Khasra No. 11 of village Kanguwala Hadbast No. 146 upto Sahadda Jaithal Deh Haja Tipra. Thence towards South along South East corner of Khasra No. 71 of village Kanguwala and along Eastern boundary of Khasra No. 587 of village Bitna Hadbast No. 153 upto Sahadda Kanguwala Deh Haja Jaithal. Thence towards South along South East corner of Khasra No. 588 of village Bitna. Thence along boundary of village Bitna and village Jaithal along Khasra No. 588 and 365 of village Bitna upto Sahadda Jaithal Deh Haja Bhuwana. Thence towards West along boundary of village Bitna and village Bhuwana boundary Khasra No. 338 and 307 of village Bitna upto North East corner of Khasra No. 53 of village Damdama Hadbast No. 114 upto Sahadda Bitna Deh Haja Bhuwana. Thence towards South upto Khasra No. 54 of village Damdama i.e. Sahadda Jungle Sarkar Deh Haja Bhuwana. Thence from Khasra No. 54 of village Damdama along boundary of Jungle Sarkar and Khasra No. 101/1, 101/2, 103,112,113,205/3,205/4,205/1 of Village Damdama and along boundary of Jungle Sarkar and Eastern boundary of Khasra No. 205/1 upto Sahadda Bhogpur Deh Haja Jungle Sarkar. Thence from North East corner of Khasra No. 40 of village Bhogpur Hadbast No. 190 i.e. Sahadda Damdama Deh Haja Jungle Sarkar towards South along South East corner of Khasra No. 97/2/1 of village Bhogpur upto Sahadda Pattan Deh Haja Jungle Sarkar. Thence towards West upto South East corner of Khasra No. 101 of village Bhogpur upto Shadda Mirpur Bakshiwala Deh Haja Pattan. Thence towards West along boundary of village Bhogpur upto South West corner of Khasra No. 171/92 of village Bhogpur and Khasra No. 14 of village Islamnagar Hadbast No. 192 i.e. Sahadda Bhogpur Deh Haja Mirpur Bakshiwala. Thence towards South along boundary of village Islamnagar and village Mirpur Bakshiwala upto South East corner of Khasra No. 427 of village Islamnagar and khasra No. 262 of village Bhagwanpur Hadbast No. 191 i.e. Sahadda Mirpur Bakshiwala Deh Haja Islamnagar thence towards South along boundary of village Bhagwanpur and Mirpur Bakshiwala upto Khasra No. 258/2/1 of village Bhagwanpur i.e. Sahadda Chak Toran Deh Haja Kotian. Thence towards South along boundary of village Bhagwanpur and Chak Dakhli Mauja Toran upto

South East corner of Khasra No. 140 of village Bhagwanpur i.e. Sahadda Toran Deh Haja Gumthala moving towards West from Sahadda Toran Deh Gumthala upto South West corner of Khasra No. 140 i.e. up to Point "C"

**South:-**Start from Point "C" to Village Gumthala Khasra No. 45,46,49,48/2,51/2,53,2,3,4/1,3,4//1/2,4/2,4/2/1,111/6/1 upto to its Northen corner i.e. Sahadda Dhanda - Gumthala - Kotian thence towards East upto North East corner of Khasra No. 111//6/2,7/1/1,7/1/1,8 upto Sahadda Kotian - Gumthala - Jungle Sarkar thence along the boundary of forest upto Southen corner of Khasra No. 9/2,12,22,24,25,26,29,31,35,40,41 i.e. Sahadda Chowki - Gumthala - Jungle Sarkar thence toward South from Khasra No. 1 of Village Chowki at Point "D" i.e. Sahadda - Ghumthala - Surajpur and Chowki hence moving along with the boundary of Municipal Corporation Panchkula upto point "E" and from Point "E" to North West along with boundary of Municipal Corporation Panchkula and revenue boundary of village Rampur Seuri, which is Sahadda Jungle Sarkari Deh Haja Rampur Seuri. Thence towards North along North West corner of Khasra No. 408/1/2 of village Rajjipur. South West corner of Khasra No. 1 Village Surajpur (Hadbast No. 109) towards North Jungle Sarkar Surajpur along North West corner of Khasra No. 1 village Surajpur up to Point "F".

**West:-**From Point "F" South West corner of Khasra No. 101 of village Manakpur Nanak Chand, North West corner of Khasra No. 88 of village Manakpur Nanak chand, South West corner of Khasra No. 1 village Manakpur Thakur Dass then towards North from Sahadda Manakpur Nanak Chand Deh Haja Jungle Sarkar, then North West corner of Khasra No. 1 of village Manakpur Thakur Dass and towards South West corner Khasra No. 1 of village Lohgarh Hadbast No. 121 towards Sahadda on Government forest land, Deh Haja Manakpur Thakur Dass on the North West corner of Khasra No. 1 of village Lohgarh, South West corner of Khasra No. 668 of village Dhamala Hadbast No. 122 Sahadda Jungle Sarkar Land then from Lohgarh towards North. Upto North West corner of Khasra No. 2 of village Dhamala hence towards South West corner of Khasra No. 12 of village Majri Jattan Hadbast No. 123 Deh Haja Jungle Sarkar land thence towards North upto North West corner of Khasra No. 12 of village Majri Jattan and thence towards North from South West Corner of Khasra No. 77 of village Khera Hadbast No. 124 North West corner of Khasra No. 58 of village Khera, South West corner of Khasra No. 3 of village Basawal Hadbast No. 125, Sahadda Jungle Sarkar thence towards North upto North West corner of Khasra No. 3 of village Baswala upto Sahadda (Trijunction) Grida Deh Haja Jungle Sarkar thence towards East upto point 'A' i.e. the point of start.




