**No. 18/81/2018-3C1 :-** In pursuance of the provision of Rule-9 of the Haryana Municipal Delimitation of Wards Rules, 1977 and in supersession of all previous orders/notifications issued in this behalf, the Governor of Haryana hereby publish the following proposal for the delimitation of the wards of **Municipal Council, Rewari, District – Rewari** for information of the persons likely to be affected thereby.

Notice is hereby given that the proposal will be taken into consideration by the Government on or after the expiry of period of 10 days from the date of publication of this order in the official gazette, together with objection and suggestion if any, which may be received by the Principal Secretary to Government Haryana, Urban Local Bodies Department /Director General, Urban Local Bodies, Haryana, Panchkula **through Deputy Commissioner, Rewari** from any person in respect of the proposal before the expiry of the period so specified :-

**Schedule of Boundaries**

**Ward No. 01 :-** Starting from the end of Municipal boundary (North-East), thence to Ajay Nagar gate moving along with boundary of Ajay Nagar and going towards South-East direction in front of Kabristan, thence after entering from this gate to boundary wall of Railway, turning from Railway park and near single storey Railway quarters, thence to the house of Mithlesh Chaturvedi after going in front of double story Railway quarters which are in ruined condition and house of Mohan Singh Yadav, thence turning towards North from the house of Raj Kumar Yadav (Ajay Nagar) towards West to S.S. Bhawan (T.T.E.), thence going towards West to house of Surender Kumar (Street of two mobile towers) in Ajay Nagar, thence moving towards South towards the house of Nitya Nand (Ajay Nagar) to that point where this Road meets Kaluwas Road, thence to the junction of Kaluwas Road and Budhpur-Berli Road going along with Kaluwas Road towards Rewari. A Shiv Mandir also situated here, thence from Budhpur-Berli Road to the western end of Municipal boundary moving towards North-West, thence going along with Municipal boundary to the junction of Rewari-Hisar Railway line and the Road in front of Loco (Heritage) shed. Thence to Bungalow of Madan Lal (Banwari Lal) moving towards South and thence to the end of North-West Municipal boundary, that is the point of start.

**Ward No. 02 :-** Starting from the junction of Rewari-Pataudi Road and Rewari-Rohtak bye pass Road where North-East Municipal boundary also meets, thence to the intersecting point of Rewari-Jhajjar Road and Rewari-Delhi Railway line (under

flyover) going along the Pataudi-Rewari Road in front of I.T.I., thence to the Road in front of Diesel Supply Centre of Railway, thence to the Road going towards Heritage Loco Shed, thence going along with this Road and in front of main gate of Loco Shed to the point where North-West municipal boundary intersects Rewari-Hisar Railway line, thence going along with this Railway line to Railway crossing (L.C.1/P2) in front of house of Munni Devi (Babulal Yadav), thence to the house of Jagdish (Ramdhan) after crossing this Railway crossing and going towards North and then towards West, thence going along with Road towards North to the point where this Road intersects Rewari-Jhajjar Road, thence going along Rewari-Jhajjar Road to the point where North boundary of Rewari-intersects Rewari-Rohtak bye pass Road, thence to the junction of Pataudi Road and Rewari-Rohtak bye pass Road, that is the point of start.

**Ward No. 03 :-** Starting from the point where North-East municipal boundary intersects Ramgarh Road, thence going towards South-West direction to Yadav Service Station, thence going along Kacha revenue Rasta to Rewari-Rohtak bye pass Road, thence to the house of Ravi Yadav (Hanuman Patwari) after going in front of vacant plot of Ramesh Saini, thence moving towards the same direction and in front of shop of Bansi Lal to the plot of Ramesh Saini, thence going towards the same direction to the junction of Nasiaji (Naya Gaon) Road and Circular Road via Aadi Fitness going towards South along with Nasiaji Road, thence to Jhajjar Chowk after going in front of Trauma Centre, thence going along with Jhajjar Road to its junction with Pataudi Road moving in front of Aggarwal Metal and crossing Rewari-Delhi Railway line, thence going along with the Pataudi Road to North-East municipal boundary crossing Rewari-Rohtak bye pass and Naya Gaon, thence moving along with municipal boundary and Kacha Rasta leading to Naya Gaon to North-East municipal boundary after going in front of house of Rajpal (Sadhu Ram) and Shyam Lal (Duli Chand), that is the point of start.

**Ward No. 04 :-** Starting from Eastern Boundary of Municipal Council, Rewari where Road to Ramgarh intersects this Boundary, thence moving towards South-East to Rewari-Sohna-Delhi Road. Thence going along this Road to the point where the HPL Factory Road and Bye-Pass meet with each other moving towards South in front of Vedic Ashram and towards Rewari, thence from this point going along the Outer Boundary Wall of HPL Factory to the H/o Rahul (Rajesh Kumar), thence moving towards West to Bye-Pass Road, Thence to the point where Bye-Pass Road intersects Ramgarh Road (Prajapati Chowk) moving towards North, thence moving alongwith Road Ramgarh to Rewari to the vacant plot situated near H/o Lajwanti (Dinesh Sharma) H-932 via moving in front of Naresh Kumar (Kabool Singh) H. No. 393, H/o Dharam Pal H-402, Mohan Dairy and H/o Vashudev (Goverdhan), thence moving towards West to H/o Daya Nand (Dharam Dass), thence moving towards the same

direction to H/o Mahipal Singh (Mangal Singh) while going after in front of H/o Dayawanti (Gopi Chand), thence to the plot of Naresh Saini adjacent to shop of Bansi Lal, thence to the point where Ramgarh Road intersects the Eastern Boundary of Municipal Council Rewari moving towards North-East and going in front of plot of Ravi Yadav (Hanuman Patwari) and near Yadav Service Station, Ramgarh Road, Eastern Boundary of Municipal Council, Rewari, that is the point of start.

**Ward No. 05 :-** Starting from the point where Northern Boundary of Municipal Council Rewari intersects Rewari-Delhi Road, thence moving towards South-West Boundary of Municipal Council Rewari where Konsiwas Road intersects the Municipal Council Rewari Boundary, thence moving along Konsiwas Road towards Rewari to the Shop of Rao Mechanical Engg. thence moving towards West and going in front of H/o Satish (Sher Singh) to Aashirwaad Property in the North Direction, thence to from the O/o Aashirwaad Properties to Rewari Bye-Pass, thence to the junction of HPL Factory Road and Bye-Pass (moving towards North and crossing Poswal Chowk and Kalaka Road, thence moving towards East and going alongwith Boundary of HPL to H/o Balkishan Soni, thence moving towards North to the O/o Haryana Appiciator, thence moving towards East to the H/o Rahul (Rajesh), thence moving towards North to Rewari-Delhi-Road, Thence moving towards East to the point where Northern Boundary of M.C. Rewari intersects Rewari-Delhi Road, that is the point of start.

**Ward No. 06 :-** Starting from the point where Konsiwas Road intersects South-East boundary of M.C. Rewari, thence going along with municipal boundary to the point of intersection of municipal boundary and Garhi Bolni Road, thence going along with Garhi Bolni Road to the junction of Garhi Bolni Road and Dhaliawas Road, thence going along with Rewari bye pass Road and towards East to Rajesh Pilot Chowk, thence to Sec-4 College moving along with bye pass Road, thence to plot of 1951 moving along with College boundary towards North-West direction, thence of plot of Arun Kumar (Plot No. 1955), thence to Gupta house (Plot No. 1873), thence to Parmod Kumar (Himanshu General Store), thence to plot of Shamsher Singh (House No. 777) going towards, thence to Model Town Thana going in front of house of Yash Pal Verma towards South-East, thence moving along with Konsiwas Road South-East to Poswal Chowk, thence to City Mall on bye pass Road, thence to the Road going towards West which intersects Konsiwas Road, thence going along the Konsiwas Road to the point where Konsiwas Road intersects South-East municipal boundary towards South-East, that is the point of start.

**Ward No.07 :-** Starting from Prajapati Chowk, moving towards South and going alongwith Bye-Pass Road to Poswal Chowk, thence from Poswal Chowk moving towards West to Sector-4 Police Station, thence going towards South to the
