No. 18/48/2018-3C1 In pursuance of the provision of Rules 3, 7 and 9 of the Haryana Municipal Corporation Delimitation of Ward Rules, 1994 and in supersession of all previous orders/notifications issued in this behalf, the Governor of Haryana hereby publish the following proposal for the delimitation of wards of **Municipal Corporation, Rohtak District Rohtak** for information of the persons likely to be affected thereby.

Notice is hereby given that the proposal will be taken into consideration by the Government on or after the expiry of period of 10 days from the date of publication of this order in the official gazette, together with objection and suggestion if any, which may be received by the Principal Secretary to Government Haryana, Urban Local Bodies Department /Director General, Urban Local Bodies, Haryana, Panchkula through Deputy Commissioner, Rohtak from any person in respect of the proposal before the expiry of the period so specified.

**Schedule of Boundaries**




